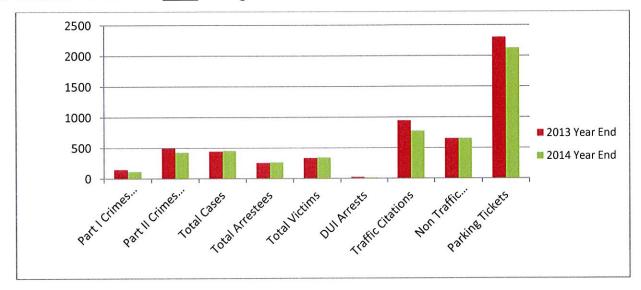

OPERATIONS: In providing the above police services in 2014 the Buffalo Valley Regional Police generated the following operational statistics. Patrol vehicles covered 197,795 miles, total in 2013 112,105 miles. The Department responded to 3,276 Calls for service; investigated 477 cases, involving 146 Part I Crimes and 585 Part II Crimes which involved 480 crime victims. These investigations resulted in 363 criminal arrest and 669 Non-Traffic Citations being issued. Traffic units investigated 214 Accidents and issued 830 Traffic Citations. There were 2127 Parking Violations issued.
